

# LOMPOC CHRISTIAN SCHOOL

## Enrollment Process

**Step 1:** Schedule a meeting with the administration. Call (805) 315-8914.

**Step 2:** Complete and return the Enrollment Application.

**Step 3:** Complete and return the **Confidential Records Request Form**, included in the Enrollment Packet. School records/transcripts are required of all applicants for grades 1-12.

**Step 4:** A parent/student interview and testing date will be scheduled after the following documents have been completed and turned in:

Copies of the results of all standardized testing  
Current year's report card  
Disciplinary records from their  
previous school Current year's  
attendance record

**Step 5:** The final forms (listed below) must be completed and submitted with payment of the non-refundable Registration Fee.

Late enrollments (after July 15): Book fees are due before the student may attend school or within 2 weeks of enrollment, whichever occurs first.

### **Admissions Criteria**

Lompoc Christian School seeks to enroll students with a desire to learn. First preference is given to returning students. Currently enrolled students who do not enroll by May 24 are not guaranteed acceptance for the upcoming school year. Preference is given to applicants whose siblings attend Lompoc Christian and satisfy the above criteria. Remaining spaces will be filled during open enrollment. All candidates are carefully considered. No student has the right to re-enrollment. All applications for re-enrollment are approved at the sole discretion of the school's administration. We strive to make a fair decision based on the services that our school can provide for each child. As well as what the student can contribute to Lompoc Christian School.

Lompoc Christian School admits students without regard to sex, race, color, national or ethnic origin. We set high goals for our students, and we expect them to work hard and strive to reach their potential with the support of their parents/guardians.

All students will be admitted to the grade level according to state stipulations. Kindergarten students must reach age 5 by December 1.

## ADMISSIONS AGREEMENT

Lompoc Christian School is a Christian school. Students and parents are also to conduct themselves in a Christian manner, both within school and at outside school functions. The following is a list of terms and conditions of admission to our school.

### **Tuition Terms and Agreements**

- The book fee is non-refundable.
- The parents or guardian are responsible for the total amount of tuition.
- Parents or guardians are responsible for making punctual tuition payments.
- A late fee of \$25.00 will be added to payments not received in the drop box by the 5<sup>th</sup> of each month.
- If an account becomes 2 months overdue, the student will be suspended from all Lompoc Christian School classes and activities until the account becomes current.
- Cash or check payments are acceptable.
- In order for report cards and transcripts to be issued, or for students to be withdrawn, there can be NO OUTSTANDING BALANCE.

### **Parent/Guardian and Student Conduct Policy**

- All parents/guardians and students will comply with the rules and regulations set forth in the Lompoc Christian School handbook.
- Students and parents/guardians will be respectful of the teachers and administration.
- Lompoc Christian School reserves the right to expel any student whose parent/guardian fail to cooperate with the administration.
- Lompoc Christian School has a no tolerance policy for student misconduct and failure to meet academic standards.
- Students that continue to violate the conduct policies or fail to meet academic expectations of Lompoc Christian School may be dismissed at the discretion of the administration.

### **Attendance Policy**

- Attendance to scheduled classes is mandatory.
- Parents or guardians must contact the school office if the student is going to be absent for any reason. (See the Parent/Student Handbook for the full policy.)
- The student will be responsible for contacting all of his/her teachers in order to obtain the homework assignments for the days missed.

- Late work during the grading period is penalized.

**Media Release**

- Parents/guardians and students hereby grant Lompoc Christian School the right to photograph, videotape, or otherwise digitally collect student’s likeness, voice, and sounds (as “Works”) during the student’s presence at Lompoc Christian School and Lompoc Christian School sponsored events and assign and grant all rights in these Works to Lompoc Christian School.
- This gives Lompoc Christian School the right to use or sublicense the Works and student names, likenesses and biographies, in Lompoc Christian School’s discretion, in all media, for the promotion of Lompoc Christian School and its mission and program.
- Lompoc Christian School events are semi-public events that may be attended by members of the press, business corporations, and media (“commercial guests”) not under the control of Lompoc Christian School who might photograph or videotape the event.
- Lompoc Christian School asks all commercial guests to comply with the Lompoc Christian School policy of not printing a minor’s name with his/her picture, and Lompoc Christian School asks them not to use images of the participants or attendees for the commercial purposes without obtaining specific written permission from the person or a minor’s parent or guardian.

*We, the parents of a LompoC Christian School student, commit to serve as collaborators with the faculty, administration, and students to achieve excellence in the educational goals for our children through academic, social, moral, and civic engagement. I pledge to do the following:*

1. In order to stay connected with my child's school experience, I agree to log in to the on-line school gradebook website twice a week for student/parent information, homework, grades, announcements and upcoming school events.
2. Support the established uniform dress code as outlined in the parent/student handbook.
3. Ensure that students arrive at least a few minutes early each day to get situated and receive instruction.
4. Facilitate the home/school communication effort by monitoring and enforcing the use of the agenda planner by the student, parent, and teacher starting in first grade.
5. Support the school's conduct codes and policies. Review this with your child so they can manage themselves better.
6. Encourage a minimum of 15-30 minutes of daily reading at home.
7. Set the bar high for your child to reach success and communicate your clear expectations for academic success. Support the daily class work, homework, and project requirements, ensuring completeness to the best of the student's ability. Acknowledge that in order to meet the Principal's Honor Roll, your child must have all A's on their report card. To meet the standards for the Merit Honor Roll, the student must have all A's and no more than two B's for students in first grade and older.
8. Ensure that student(s) participating in extracurricular activities is/are picked up on time, as indicated by the permission slip and acknowledge that late fees of \$1 per minute will apply.
9. Attend a minimum of two in-school parent/teacher conferences per year to discuss your student's progress.
10. Submit updated student and parent information to the office within seven calendar days of any changes.
11. Follow the Health and Safety policies of the school and keep children home until well and fever free at least 24 hours.
12. In the collective effort to support the school financially through fundraisers, I acknowledge that there will be a required sales goal for each fundraiser. I accept that this sales goal must be met by my student(s) by sale or by compensation.
